# What do we actually do?


## Bridging the gap between industry and government

- Monitoring sustainability-related policy and providing updates to members.
  - Direct engagement with government departments such as DESNZ, Defra, FCDO, DBT and others.
  - Responding to consultations, calls for evidence and parliamentary inquiries.
  - Engaging with politicians, including those from the opposition.

## Addressing environmental and human rights risks within tech

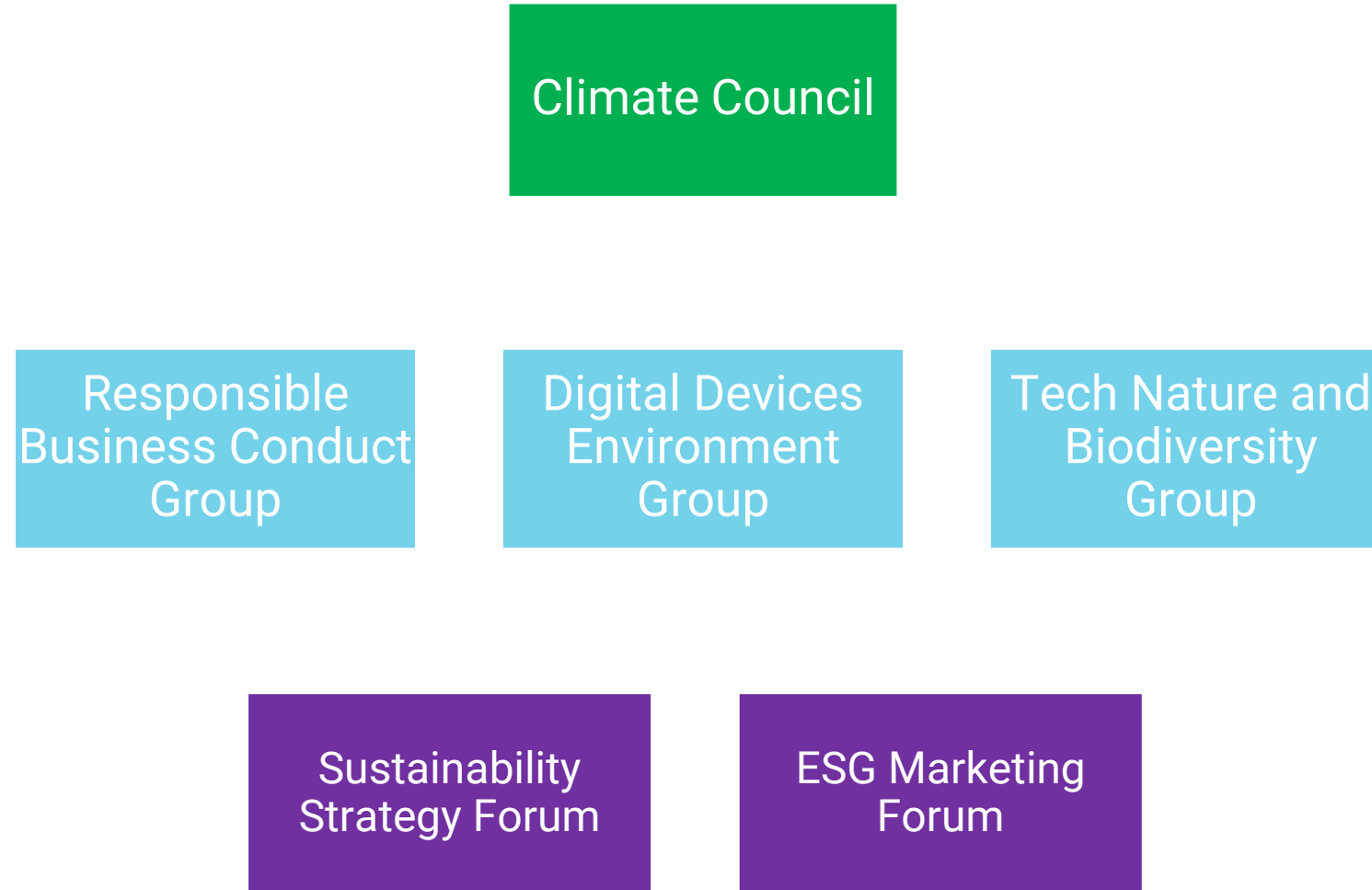
- Speaking to members about potentially negative impacts of technology on sustainability and human rights.

# Government engagement and lobbying

- We regularly speak to various government departments and respond to their consultations or calls for evidence.
- Parliamentary engagement includes responding to inquiries, both verbally and in writing:
  - Response to a consultation on the introduction of a UK CBAM
  - Response to a call for evidence on Scope 3 reporting
  - Response to an inquiry on the Modern Slavery Act 2015
  - Select committee appearance on modern slavery in tech supply chains
  - Response to a consultation and Call for Evidence on e-waste
- We interact with MPs, including those from the opposition, e.g. we organised a roundtable on human rights due diligence with Alex Davies-Jones in May 2024.

# Programme structure

## Climate Council

- Focus areas include climate resilience, net zero transition, green digital skills, decarbonisation.
- Elected for a 2 year term, meets every 6-8 weeks.
- Current workstreams include a document summarising techUK's policy recommendations on various sustainability-related topics, as well as creating a wider net zero transition guide for the tech sector.
- This group sets the techUK position on different climate issues and acts as the group of members that approves what we say, think and do on climate and the net zero transition.
- Priorities are green-ops (green skills and green software), adaptation and resilience and promoting the adoption of digital tech.
- The Council does not execute the work though – Council and wider membership can get involved so it isn't a closed shop.

### Responsible Business Conduct Group

- Topics covered: sustainability reporting, human rights due diligence, forced labour, critical minerals, modern slavery statements, supply chain transparency.
- Each meeting includes a policy update, as well as short topical presentations on various topics.
- Meetings occur quarterly, however we do ad-hoc calls/meetings on key issues.

### Digital Devices Environment Group

### Tech Nature and Biodiversity Group

- Topics covered: nature-related disclosures, water conservation, biodiversity net gain regulations, nature tech.
- Each meeting includes a policy update, as well as short topical presentations on various topics.
- Meetings occur three times a year, but we do topical webinars more frequently.

### › Sustainability Strategy Forum

- Sustainability Strategy Forum is a platform for members to engage in higher-level discussions about key aspects of digital sustainability.
- Meetings occur quarterly, with each session lasting 1.5 hours. Volunteer speakers, chosen on a first-come, first-serve basis, present their approaches, outlining both the advantages and challenges they have encountered. Each meeting selects a topic for the next session.
- Open to all techUK members, the Forum invites those who are committed to both giving and receiving insights.
- Operates under the Chatham House rule, fostering an environment where companies can openly share success stories, address pain points, and provide constructive feedback.

- ESG Marketing Forum serves as a platform for professionals in marketing, communications, PR, and public affairs.
