

All-Party Parliamentary Group for Broadband and Digital Communication Meeting Minutes: Gigabit rollout update 10/02/2021

Opening

The meeting of the APPG for Broadband and Digital Communication was called to order at 14:00 on 10/02/2021 by Selaine Saxby MP. Selaine welcomed the new secretariat techUK, and our speakers for today's event: gigabit rollout update.

Industry speakers

- Catherine Colloms, Openreach: view from largest fibre builder in the UK that industry needs additional help with deployment from government (access to properties; business rates relief), and an environment that encourages investment.
- Alex Blowers, CityFibre: view that the investment case is also gated by the regulatory framework (conclusion of <u>Ofcom WFTMR</u>), which needs to closely align with government target. Raised the issue of increasing digital divide in urban, as well as rural, areas through issues with landlords and access.
- Daniel Butler, Hyperoptic: view from urban gigabit operator that significant barriers remain to deployment, though it is welcome that government recognises and is looking to resolve issues such as engagement with local authorities and social landlords.
- Ed Leighton, Ofcom: Outlined how the regulator had shifted position to help promote competition. The regulatory framework (WFTMR) will adopt a tailored approach for rural areas (not commercial). Also, Ofcom focused on how to boost take-up of gigabit services by consumers.

Q&A and open issues

- Digital exclusion and increasing access to gigabit:
 - DCMS is consulting on changes to the <u>Electronic Communications Code</u> ("ECC");
 - The <u>Telecommunications Infrastructure (Leasehold Property) Bill</u> ("TILP") returns to House of Commons on 24/02/2021;
 - Industry working with housebuilders to ensure fibre connections in new build developments
- Clarity for consumers:
 - Ofcom has recently announced <u>new plans for switching</u> ('OneTouch') to help consumers:
 - Industry, government and Ofcom working together to raise awareness and increase understanding of what's available, and boost take up (<u>GigaTAG</u>)
- Transparency:
 - Darren Henry requested a map of the planned rollout of full-fibre in Broxtowe, Nottingham;
 - Openreach voluntarily publishes its build plans 2-3 years in advance, though due to complexity, rollout is determined on a case-by-case basis — For any casework or local issues, you can contact Openreach on parliamentary.help@openreach.co.uk;



 On what areas are designated urban or rural, some rules are determined by DCMS, Ofcom's tailored approach, and industry on what is commercial. Sharing of credible build plans by industry was encouraged.
