### Our work focusses on:

### 1. Policy advocacy



- > We provide the means to formulate industry positions to Government, offering an environment in which companies can come together to reach consensus
- > techUK advocates these positions on behalf of industry to key stakeholders within the NHS, central Government, local authorities, and other bodies such as the MHRA and NICE

### 2. Market engagement



- > techUK aims to lead the debate on new technologies and provide a forum for government, NHS, and social care representatives to engage with tech suppliers
- We help government access leading industry expertise at an early stage in tackling challenges, and help our members improve their understanding of government requirements

# NHS Transformation Directorate

techUK held a strategic partnership with NHS Digital from 2017. Since the merger of NHS Digital and NHSX, techUK continues to work closely with the Transformation Directorate to hold workshops, conferences, consultations and more





### Integrated Care Systems

We hold regular industry briefings with ICS and Trust CIOs across the country, providing our members with the chance network and influence the ecosystem, with the aim of ultimately helping to improve outcomes for staff and patients

#### **Social Care Working Group**

The Social Care Working Group identifies common challenges and solutions, offering the opportunity to leverage partnerships.

The Working Group provides members with the chance to connect with national and local stakeholders, such as NHS England's Digital Adult Social Care team and ADASS to better understand their digital vision and challenges, and how industry can help.

### **Life Sciences Working Group**

techUK's Life Sciences Working Group brings together members working in drug discovery, digital therapeutics, data and Al.

As the Life Sciences sector looks to introduce digital health technologies into its portfolio, techUK are working with members to **shape the conversation** and highlight the **role of tech** in making the UK a life sciences superpower.

#### Interoperability & Health Data Forum

techUK's Interoperability Forum strives to achieve the vision set out in NHS England's standards and interoperability strategy.

The Forum encompasses the broader agenda of health data, including Secure Data Environments, Interoperability, and integration with Social Care. The Forum provides members the opportunity to provide direct feedback to NHSE, and allows NHSE to receive a comprehensive range of industry perspectives.

### Frontline Digitisation Working Group

techUK has been working with the NHS England Frontline Digitisation team since February 2022, forming a partnership to bring together EPR vendors.

Meetings with members of the groups are organised monthly, with companies getting the opportunity to engage directly with the programme team and share insights and feedback to help shape the direction of travel.

#### **Commercial & Procurement**

techUK works with the Digital and Technology Category Team in the Commercial Directorate at NHS England. Our regular meetings provide an opportunity for open discussion regarding challenges in procurement processes.

Our members share best practice, explore challenges and opportunities around procurement frameworks and routes to market, and receive regular updates from the procurement team on work to improve processes.

#### Al in Health & Care

2023 was a pivotal year for artificial intelligence. In 2024, techUK will host 3 roundtables focusing on areas where can has the greatest potential to transform health and care:

- 1. Clinical-decision making support
- 2. Back office and administrative transformation
- 3. Patient engagement

These will be followed by a positions paper to highlight potential areas for concern and attention.

#### **Health & Care SME Forum**

This Forum gives businesses working across health and care the opportunity to further their development within the sector, connect with peers and potential collaborators, and engage with key government and industry stakeholders.

The group will seek to tackle issues such as lack of reimbursement pathways for novel technologies, perceived risk associated with SMEs, and more.

### **Spotlight Series**

To explore new topics and provide opportunities for our members to become thought leaders, we host a Spotlight Series, highlighting emerging or contentious issues in health and care technology, for example:

- 1. Digital therapeutics
- 2. Virtual wards
- 3. Digital skills and leadership
