- Facilitating strategic briefings with government, providing members with valuable insights and opportunities to influence key policy issues, including the Cyber Security and Resilience Bill.
- Delivering sector specific events with key stakeholders, industry specific trade and regulatory bodies to understand key challenges and opportunities, connecting cyber members together with industry counterparts.
- Championing the cyber ecosystem by advocating for SMEs, building
 partnerships with stakeholders across regions and nations and spotlighting
 initiatives that enhance skills, innovation, and diversity within the sector.

Our Cyber Resilience Programme offers members working across the UK cyber ecosystem the opportunity to network, share ideas and collaborate, enabling the industry as a whole to address common challenges and opportunities together. The Programme holds market engagement sessions across public and private sectors and the exports market, providing industry with market intelligence and practical advice on how to engage key partners.

Influence Policy

techUK champions industry perspectives on the development of key legislation and regulation. We have high-level relationships with key government departments including DSIT, Cabinet Office, NCSC and Home Office, and we provide the secretariat for the Cyber Growth Partnership, the industry–government conduit for growing the sector. These initiatives help members to create the best environment for growth.

techUK continues to explore how industry can strengthen the role it plays in delivering the National Cyber Strategy and Government Cyber Security Strategy. We run market engagement events to explore key markets across CNI and 4IR. We also work with DBT to engage key international partners across the 5-Eyes, Gulf and emerging economies. This approach helps members to understand the opportunities in the sector.
