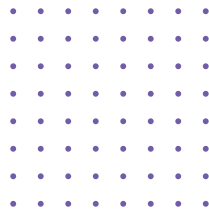

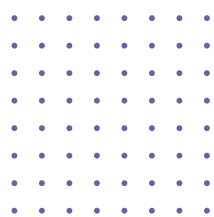

## Shannon Coe

**Director of Global Data Policy, International Trade  
Administration, U.S. Dept. of Commerce**



Shannon is the Director of Global Data Policy in the U.S. Department of Commerce, International Trade Administration. In this capacity, she manages a team that focuses on policy issues affecting global cross border data flows that support international trade. Shannon leads the United States' participation in the recently established Global Cross Border Privacy Rules Forum and oversees the U.S. efforts to implement the APEC Cross Border Privacy Rules System. Shannon leads the U.S. delegation in the APEC Digital Economy Steering Group and the Data Privacy Subgroup. She was a key member of the team that negotiated the 2016 EU-U.S. and Swiss Privacy Shield Frameworks, led the implementation of the programs, and oversaw the first annual review. Prior to joining ITA, Shannon worked on a variety of international trade issues as an attorney in the Office of Chief Counsel for International Commerce of the Department of Commerce and as a transactional attorney in a NYC law firm.

## Sue Daley

**Director, Technology and Innovation, techUK**



Sue leads techUK's Technology and Innovation work.

This includes work programmes on cloud, data protection, data analytics, AI, digital ethics, Digital Identity and Internet of Things as well as emerging and transformative technologies and innovation policy. She has been recognised as one of the most influential people in UK tech by Computer Weekly's UKtech50 Longlist and in 2021 was inducted into the Computer Weekly Most Influential Women in UK Tech Hall of Fame. A key influencer in driving forward the data agenda in the UK Sue is co-chair of the UK government's National Data Strategy Forum. As well as being recognised in the UK's Big Data 100 and the Global Top 100 Data Visionaries for 2020 Sue has also been shortlisted for the Milton Keynes Women Leaders Awards and was a judge for the Loebner Prize in AI. In addition to being a regular industry speaker on issues including AI ethics, data protection and cyber security, Sue was recently a judge for the UK Tech 50 and is a regular judge of the annual UK Cloud Awards.

Prior to joining techUK in January 2015 Sue was responsible for Symantec's Government Relations in the UK and Ireland. She has spoken at events including the UK-China Internet Forum in Beijing, UN IGF and European RSA on issues ranging from data usage and privacy, cloud computing and online child safety. Before joining Symantec, Sue was senior policy advisor at the Confederation of British Industry (CBI). Sue has an BA degree on History and American Studies from Leeds University and a Masters Degree on International Relations and Diplomacy from the University of Birmingham. Sue is a keen sportswoman and in 2016 achieved a lifelong ambition to swim the English Channel.

### **Dr Deborah Elms**

#### **Founder and Executive Director, Asian Trade Centre**

Dr. Deborah Elms is the Founder and Executive Director of the Asian Trade Centre and the President of the Asia Business Trade Association.



Concurrently, she is a member of APCO's International Advisory Council, the G20 Trade and Investment Research Network, and the Advisory Board of the Trade and Investment Negotiation Adviser at the United Nations Economic and Social Commission for Asia and the Pacific. She is also a Research Associate at the New Zealand APEC Study Centre and a Senior Fellow of the Ministry of Trade and Industry Academy of Singapore.

Dr. Elms has extensive experience working with governments, international organizations, businesses, and the academe and is one of the leading experts on trade policy in the region. She was also active in her past leadership posts in international trade groups having served on the Trade and Investment Council of the World Economic Forum from 2017 to 2019, the International Technical Advisory Committee of the Global Trade Professionals Alliance, as well as being the chair of its Working Group on Trade Policy and Law.

Prior to her current role, Dr. Elms was head of the Temasek Foundation Centre for Trade and Negotiations and Senior Fellow of International Political Economy at the S. Rajaratnam School of International Studies at Nanyang Technological University in Singapore.

### **Martina Ferracane**

**Post-Doctoral Research Fellow, European University  
Institute**



Martina is passionate about policy-making and technological innovation. She is a post-doctoral researcher focussing on digital trade and data flows at the European University Institute and she acts regularly as a consultant for several institutions including the United Nations, the World Economic Forum and the World Bank. On top of regulatory issues connected to data flows, including trade governance, cybersecurity and privacy, her research covers topics related to digital transformation and digital education. Martina founded and manages FabLab Western Sicily, a non-profit organisation that brings creative digital education to Sicilian schools and she was listed in Forbes 30 Under 30 for her work with Oral3D, a start-up she co-founded in the area of 3D printing and dentistry. For her work in these areas, she was listed in 2018 among the 15 most influential Italian women on digital issues.

### **Helani Galpaya**

**Chief Executive Officer, LIRNEasia**



Helani Galpaya researches and engages in public discourse on issues related to net neutrality, policy and regulatory barriers in Internet access, e-Government and broadband quality of service. She also studies and speaks on how knowledge and information disseminated via ICTs can improve inclusiveness of SMMEs (small, medium and micro enterprises) in global agriculture value chains, and how labor is changing due to digitization and entry of digital platforms that reduce transaction costs. She is currently leading nationally representative surveys of Internet use by households and individuals in India, Pakistan, Bangladesh, Indonesia, Cambodia, Myanmar and Nepal. She is also currently researching how experiences and perceptions of harassment, surveillance and privacy impact the way men and women differentially experience the Internet, and how online identity helps or hinders their digital and political participation.

Helani serves on the Board of Editors of the Information Technology and International Development (ITID) journal, is on the Board of Directors of the Global Partnership for Sustainable Development Data (GPSDD), and a member of the Working Group on Innovation and Commercialisation of the Global Partnership on AI (GPAI).

She was a member of the Multistakeholder Advisory Group (MAG) of the UN Internet Governance Forum, the Advisory Board of the Harnessing and Sharing Economy for Local Development initiative of the Centre for Implementation of Public Policies promoting Equity and Growth (CIPPEC), Argentina and an Advisor to the UN Broadband Commission's Working Group on Bridging the Gender Divide.

Helani previously worked at the ICT Agency of Sri Lanka implementing the World Bank's e-Sri Lanka initiative. Prior to that she was a management consultant at Booz&Co (formerly Booz Allen Hamilton), New York, and worked at Citibank and Merrill Lynch in New York and Miami. She has an MSc in Technology & Policy from the Massachusetts Institute of Technology, Cambridge, USA and a BA (Cum Laude) in Computer Science from Mount Holyoke College, Massachusetts, USA.

### **Javier Lopez Gonzalez** **Senior Trade Policy Analyst, OECD**

Javier López González is a Senior Economist at the Trade and Agriculture Directorate of the OECD. His recent work focuses on issues related to trade in the digital era: developing frameworks for the analysis of digital trade, including in the context of exploring what market openness means in the 21st century; investigating regulatory approaches to cross-border data flows; and identifying potential economic costs and benefits of digital trade. He has previously worked on the drivers and implications of participation in global value chains. Javier holds a PhD in Economics from the University of Sussex.

Ada Igboemeka is the Deputy Director for Digital Trade and Telecoms at the Department for International Trade where she heads the team of international negotiators who are working on the digital and telecoms chapters for FTAs with partners such as Canada, India, Mexico and the Gulf Corporation. Her team also leads the UK's multilateral negotiations on E-commerce at the World Trade Organisation (WTO). Before this, Ada was Deputy Director for Multilateral Tariffs where she led her team to deliver the UK's independent domestic tariff regime upon exiting the EU, as well as having responsibility for the UK's policy and negotiations on Trade in Goods at the WTO. She has also been DIT's chief negotiator for trade in Intellectual Property, Government Procurement and Climate and Environment. She started her career in the civil service working on international development policy, including heading up what is now the Foreign, Commonwealth and Development Office's trade and international development programme.
